**ARTICLES OF INCORPORATION  
OF

Pursuant to the Florida Business Corporation Act, the undersigned incorporator submits these Articles of Incorporation for the purpose of forming Thrive Events, Inc. (the "Corporation"), a for profit corporation.

**ARTICLE I  
CORPORATE NAME**

The corporate name for the Corporation is **Thrive Events, Inc.**

**ARTICLE II  
STREET ADDRESS AND MAILING ADDRESS**

CAPITAL STOCK: NUMBER OF SHARES**
