**ARTICLES OF INCORPORATION
OF
UNI-SCRIPT PHARMACY, INC.**

The undersigned, acting as incorporator of UNI-SCRIPT PHARMACY, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is UNI-SCRIPT PHARMACY, INC. (the "Corporation").
