ARTICLES OF INCORPORATION**HEF-QUAIL ROOST VI, INC.**

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

FIRST: The corporate name of the corporation (hereinafter called the "Corporation") is HEF-QUAIL ROOST VI, INC.

SIXTH: The purpose for which the Corporation is organized is as follows:


