## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF LAFAYETTE BANKING COMPANY

Lafayette Banking Company, a corporation organized and existing under the laws of the State of Florida, in accordance with the provisions of Section 607.1006 of the Florida Business Corporation Act does hereby amend its Articles of Incorporation as follows.

Article IV is amended and replace in its entirety by the following:

## "ARTICLE IV. SHARES

Section 1 - Classes of Stock: The total number of shares of all classes of capital stock which the Corporation shall have authority to issue is 15,000,000, consisting of:

- A. 2,500,000 shares of preferred stock, par value two dollars (\$2.00) per share ("Preferred Stock"); and
- B. 12,500,000 shares of common stock, par value (\$1.00) per share ("Common Stock"). Each holder of shares of Common Stock shall be entitled to one vote per share."
