



6. I wish to domesticate the Maryland Corporation and require the use of the name, CFI Technologies Inc. being held by the Florida Corporation.

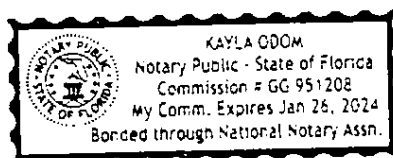
