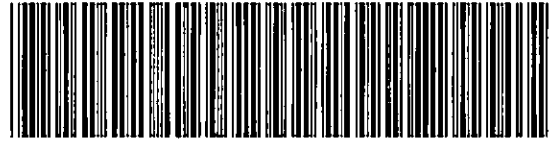

This corporation shall begin its corporate existence on the day these articles are filed with the State of Florida, Secretary of State.

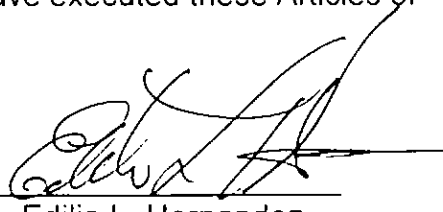
ARTICLE IX - BY-LAWS

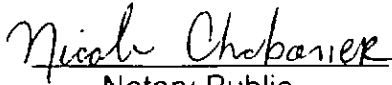

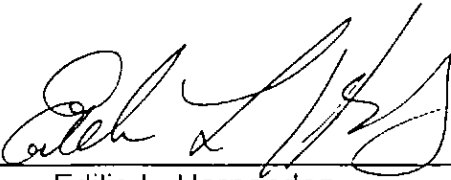
