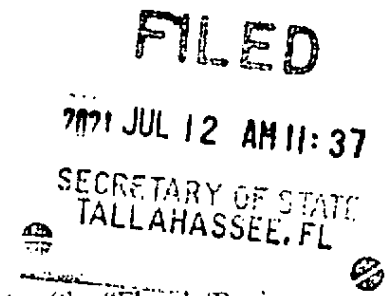

**ARTICLES OF INCORPORATION  
OF  
GWG HOME, CORP.**



Pursuant to the provisions of Chapter 607 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned incorporator, for the purposes of forming a Florida profit corporation, hereby adopts the following Articles of Incorporation:

**ARTICLE 1  
NAME**

The name of the corporation is GWG HOME, CORP. (the "Corporation").

**ARTICLE 2  
DURATION, PLACE OF BUSINESS AND MAILING ADDRESS**

The period of duration of the Corporation is perpetual and its principal place of business is located at 15981 Citrus Knoll Drive, Winter Garden, FL 34787. The Corporation's mailing address will be at 407 Lincoln Road, Penthouse NE, Miami Beach, Florida 33139. The Corporation may also maintain an office or offices at such other place or places, either within or without the State of Florida as may be determined, from time to time, by the Board of Directors.

**ARTICLE 3  
PURPOSE**

The purposes for which the Corporation is organized are to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

**ARTICLE 4  
SHARES OF STOCK**
