**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Florida business corporation:

**ARTICLE I  
Name**

The name of the Corporation shall be Las Naples 4630 Inc.

**ARTICLE II  
Purpose**
