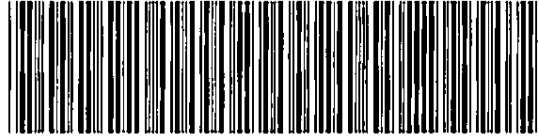

FOURTH: None of the corporation's shares have been issued.


FIFTH: No debt of the corporation remains unpaid.
