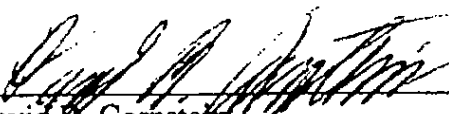

**ARTICLES OF
INCORPORATION**

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit) (the "Act")

ARTICLE I - NAME:

The name of the corporation (which is hereinafter called the "*Corporation*") shall be:

PINNACLE ADVISORS CORP.

ARTICLE II - PRINCIPAL OFFICE:

The present address of the principal office of the Corporation is 100 Worth Avenue, Penthouse 14, Palm Beach, FL 33480.

ARTICLE III - PURPOSE:

The purposes for which and any of which the Corporation is formed and the business and objects to be carried on and promoted by it are:

- (1) To engage in any lawful act or activity which may be carried on by a corporation under the Act; and
- (2) To do and perform all acts necessary or desirable to carry out the foregoing purpose.

The foregoing enumerated purposes and objects shall be in no way limited or restricted by reference to, or inference from, the terms of any other clause of this or any other Article of the charter of the Corporation, and each shall be regarded as independent; and they are intended to be and shall be construed as powers as well as purposes and objects of the Corporation and shall be in addition to and not in limitation of the general powers of corporations under the Act.

ARTICLE IV - SHARES:

The total number of shares of stock of all classes which the Corporation has authority to issue is 200 shares of Common Stock no par value per share.

ARTICLE V - INITIAL DIRECTORS:

The number of directors of the Corporation shall be one (1), which number may be increased, and thereafter decreased, pursuant to the By-Laws of the Corporation, but

shall never be less than the minimum number permitted by the Act. The names and addresses of the directors who will serve until the first annual meeting and until their successors are elected are:

ARTICLE VI - REGISTERED AGENT:

The name and address of the registered agent of the Corporation is David B. Cornstein, 100 Worth Avenue, Penthouse 14, Palm Beach, FL 33480.

ARTICLE VII - ADDITIONAL PROVISIONS:

The following provisions are hereby adopted for the purpose of defining, limiting and regulating the powers of the Corporation and of the directors and stockholders:

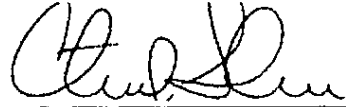
- (1) The Corporation reserves the right from time to time to make any amendments of its charter which may now or hereafter be authorized by law, including any amendments changing the terms or contract rights, as expressly set forth in its charter, of any of its outstanding stock by classification, reclassification or otherwise; but no such amendment which changes such terms or contract rights of any of *its outstanding* stock shall be valid unless such amendment shall have been authorized by not less than a majority of the aggregate number of the votes entitled to be cast thereon, by a vote at a meeting or in writing with or without a meeting.
- (2) The power to adopt, alter, amend or repeal By-Laws will be vested in the Corporation's Board of Directors.

The enumeration and definition of particular powers of the Board of Directors included in the foregoing shall in no way be limited or restricted by reference to or inference from the terms of any other clause of this or any other Article of the charter of the Corporation, or construed as or deemed by inference or otherwise in any manner to exclude or limit any powers conferred upon the Board of Directors under the applicable laws of the State of Florida now or hereafter in force.

ARTICLE VIII - INCORPORATOR:
