The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby concur to form a corporation under the laws of the State of Florida, Chapter 607, Florida Statutes and certify as follows:

ARTICLE I

The name of the corporation shall be **REMINISCENTS, CORP**, for convenience the corporation shall be referred to in this instrument as the corporation. The principal place of business of this corporation shall be 16400 SW 173RD Avenue, Miami, FL 33187.

ARTICLE II

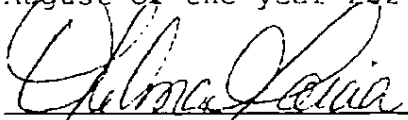
ARTICLE VIII

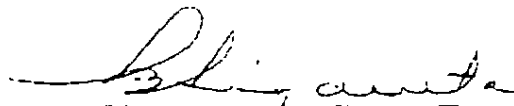
