USA fire esprinkles Corp.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 3 of which 1 shares of par value \$500 per share shall be designated as Common Stock and 2 shares of par value \$500 shall be designated as Preferred Stock.
