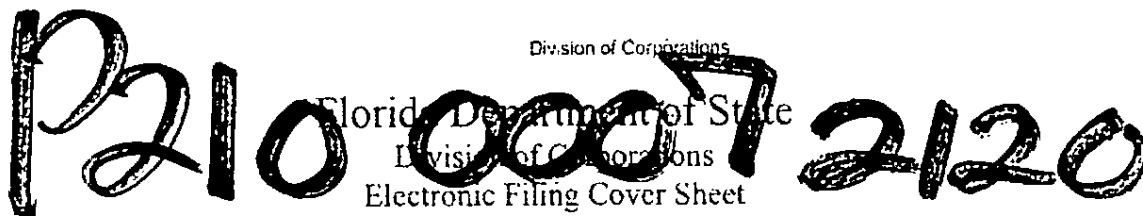

**Article I  
Name**

The name of this corporation is FLORIDA LUXURY RESIDENCE INN CORP.

**Article II


