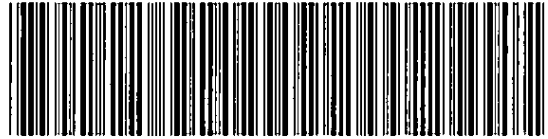

The name of the corporation is One More Toy, Inc. (hereinafter called the "Corporation").

The name of the Incorporator is Gary Markel and the address of the Incorporator is 815 21st Court South, Naples, Florida 34102.

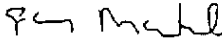
