The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, in compliance with Chapter 607 and/or Chapter 621, F.S.(Profit), adopt (s) the following Articles of Incorporation for such corporation.

ARTICLE I, NAME

The name of the corporation shall be **Namaste Gorgie Inc.**

ARTICLE II, PRINCIPAL OFFICE

The Initial street address in Florida of the initial registered office of the corporation is 1470 NW 107 Avenue Suite E Miami, FL 331 72. But the Board of Directors may from time to time, move the principal place of the office to any other address in the State of Florida.

ARTICLE III, SHARES

The number of shares that the corporation shall have the authority to issue is 1000 shares at \$1.00 per share. Such stocks may be issued by the Corporation from time to time for such consideration as may be fixed by the Board of Director thereof, and may be paid in cash, labor, or service.

ARTICLE IV, PURPOSE

To purchase the corporate assets or any other Corporation and engage in the same or other character of business. To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds,

securities, or other evidence of indebtedness created by any other corporation on the State of Florida or any other State or government and while owner of such stock to exercise all rights, powers and privileged of ownership, including the right to vote such stock.

ARTICLE V, INITIAL OFFICER(S) AND/OR DIRECTOR(S)




