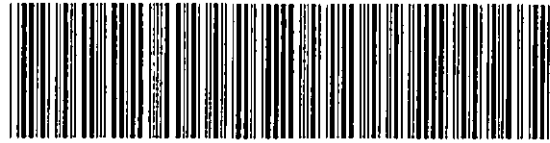

ARTICLES OF INCORPORATION
OF
Shasher Consulting Group, Incorporated

I, the undersigned natural person over the age of twenty-one (21) years or more, citizen of the State of Florida, acting pursuant to Chapter 607 and 621 Florida Statutes, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

NAME

The name of the corporation is **Shasher Consulting Group, Incorporated.**

ARTICLE II

DURATION

The period of its duration is perpetual.

ARTICLE III

PURPOSE

The purpose for which this corporation is organized is to provide consulting services, real estate services, as well as transact any and all lawful business for which a corporation may be incorporated under Chapter 607 and 621 Florida Statutes.

ARTICLE IV

SHARES

The aggregate number of shares, which the corporation has authority to issue, is 1,000,000 shares with par value of \$1.00 each. The shares are designated as common stock and have identical rights and privileges in every respect.

ARTICLE VII


BYLAWS
