# ARTICLES OF INCORPORATION OF STEPHEN T. FOLEY ENTERPRISES, INC.

The undersigned incorporator, for the purpose of forming a corporation under Chapter 607, F.S., the Florida for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

### **ARTICLE I – NAME**
