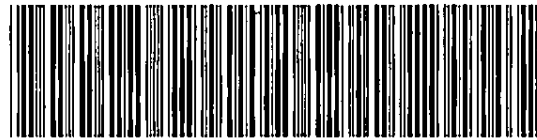

ARTICLES OF INCORPORATION
OF
INDIGO SCEPTER, INC.

The undersigned incorporator to these articles of incorporation hereby forms a corporation (the "Corporation") under the laws of the State of Florida as follows:

ARTICLE I

Name

The name of the corporation is Indigo Scepter, Inc.

ARTICLE II

Initial Principal Office and Mailing Address

The corporation's initial principal office and mailing address is 2665 Gulf Breeze Parkway, Gulf Breeze, FL 32563.

ARTICLE III

Shares

The corporation shall have authority to issue 100 common shares, no par value.

ARTICLE IV

Initial Registered Agent and Office

ARTICLE VI

Purpose

The purpose of the Corporation is to engage in any lawful act, activity or business for which a corporation may be organized under the Florida Business Corporation Act.

ARTICLE VII
Indemnification

No director of the corporation shall be personally liable to the corporation or its shareholders for monetary damages to the corporation or any other person for any statement, vote, decision or failure to act, regarding corporate management or policy, as a director, except to the extent that such exemption from liability or limitation thereof is not permitted under the Florida Business Corporation Act.

The corporation shall indemnify to the full extent permitted by law any person who is made, or is threatened to be made, a party to any action suit or proceeding (whether civil, criminal, administrative or investigative) by reason of the fact that he or she is or was a director or officer of the corporation or serves or served any other enterprises at the request of the corporation. If the Florida Business Corporation Act is amended after the filing of these Articles of Incorporation of which this Article VI is a part to authorize corporate action further eliminating or limiting the personal liability of directors, then the liability of a director of the corporation shall be eliminated or limited to the fullest extent permitted by the Florida Business Corporation Act as so amended.

Any repeal or modification of the foregoing paragraph by the shareholders of the corporation shall not adversely affect any right or protection of a director of the corporation existing at the time of such repeal or modification.

ARTICLE VII
Perpetual Existence

The corporation shall have perpetual existence.

ARTICLE VIII
Initial Director

The powers of the incorporator are to terminate upon the filing of this Articles of Incorporation, and the name and mailing address of the person who is to serve as the initial director until the first annual meeting of stockholders or until his successor is elected and qualified is:

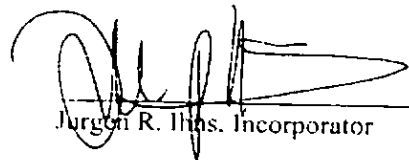

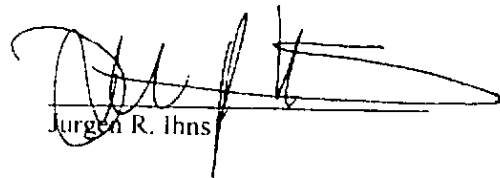
