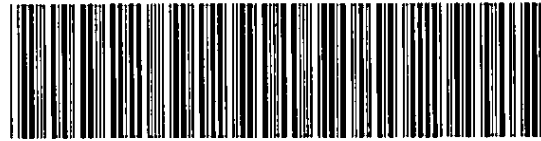

**ARTICLE I - NAME**

The name of this corporation is Revels Land and Cattle, Inc.



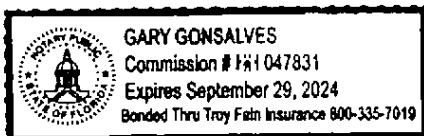


