

No amendment or repeal of this article, nor the adoption of any provision of these Articles of Incorporation inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal, or adoption.

# ARTICLE VI Loan Provision

For so long as (i) the Loan is outstanding pursuant to the Note, the Loan Agreement and the other Loan Documents, and/or (ii) the Mezzanine Loan is outstanding pursuant to the Mezzanine Loan Documents, the Corporation shall not file or consent to the filing of any petition, either voluntary or involuntary, to take advantage of any applicable insolvency, bankruptcy, liquidation or reorganization statute, or make an assignment for the benefit of creditors without the affirmative vote of each Independent Director and of all other directors.
