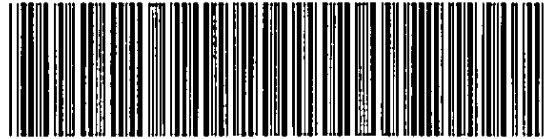

We hereby associate to form a stock corporation under the provisions of Section 607.0202 of the Florida Statutes, and to that end, set forth the following:

(1) The name of the corporation is:

(2) The purpose or purposes for which the corporation is organized are:
