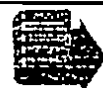
The Corporation shall engage in any activity and all lawful business permitted under the laws of the United States and of the State of Florida.


