**ARTICLES OF INCORPORATION  
OF

**THE UNDERSIGNED**, acting as sole incorporator of **Sharr Holdings, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I.  
NAME**

The name of the corporation is **Sharr Holdings, Inc.**

**ARTICLE II.  
SHARES**

The authorized number of shares which the corporation shall have the authority to issue is 100,000, consisting of 1,000 shares of Class A Common Stock and 99,000 shares of Class B Common Stock, each with the par value of \$1.00 per share. The rights and preferences granted to the holders of the Class A Common Stock and Class B Common Stock are identical, except that the holders of the Class A Common Stock shall be entitled to one vote per share on all matters submitted to the shareholders for a vote, and the holders of the Class B Common Stock shall have no voting rights.

**ARTICLE III.  
COMMENCEMENT OF CORPORATE EXISTENCE**

In accordance with Section 607.0203(1), Florida Statutes, the Corporation's corporate existence shall be deemed to have commenced upon the date on which these Articles of Incorporation are filed with the Florida Department of State.




