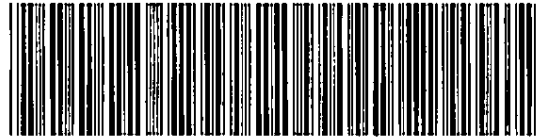

To whom it may concern:

Articles of Incorporation (Articles) for Big Moose, Inc. were filed with the Florida Department of State Division of Corporations (DOC) on November 24, 2021. An application to register the fictitious name, Big Moose Group, was subsequently filed shortly thereafter and approved by the DOC on December 1, 2020. Since the time of these initial filings, issues have arisen for which resolution necessitates modification of the Articles. This letter incorporates three exhibits.

- Exhibit 1 provides a markup showing modifications made: a) through the Articles of Correction in red; and B) under the Articles of Amendment in blue.
- Exhibit 2 includes the DOC standard Cover Letter, Articles of Correction, and \$35 check as payment for the filing fee.
- Exhibit 3 includes the DOC standard Cover Letter, Articles of Amendment, and a cheque for \$43.75 as payment for the filing fee as well as the issuance of a Certificate of Status.

**Articles of Correction**

The Articles of Correction address an error discovered in the Articles as initially filed by ZenBusiness, Inc. (ZenBusiness). Zenbusiness had been hired to serve as the Registered Agent for the company as well as to assist us with the incorporation process. As part of these efforts, ZenBusiness prepared a draft set of Articles, which we reviewed and approved, and which specifically instructed them to elect use of DOC's standard language (i.e. "any and all legal business.") by checking the box under Article III. Typically ZenBusiness assigns one staff member to prepare and submit the required incorporation documentation. In this case, ZenBusiness assigned a staff member with little prior experience in Florida. Based upon his work in other jurisdictions, he had concerns that the standard language could be considered too vague or generic a response. To proactively avoid a potential delay should this be the case, he disregarded the approved draft, opting

marketing brochures. Unfortunately, this text was crafted specifically for one segment of our business and does not provide an accurate reflection of the breadth and scope of the services we provide nor of our relationship with ZenBusiness. Upon notifying ZenBusiness of this error, they contacted the DOS to determine the procedure to make corrections and were instructed to submit the Articles of Correction, which we are doing here. The specific revisions necessary include striking the entire paragraph under Article III and replacing it with the standard language as shown in Exhibit 1. The actual Articles of Correction are included in Exhibit 2.

## Articles of Amendment

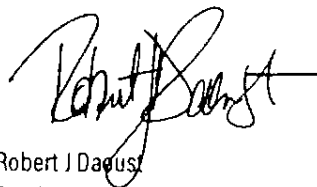
Exhibit 3 includes the Articles of Amendment under which several revisions to the Articles are being executed. These Articles of Amendment were discussed and approved unanimously at a Shareholders Meeting held on December 27, 2021. The revisions include:

- *Update to our Registered Agent* — Aside from the error discussed above, there were other issues with ZenBusiness' services resulting in our decision to terminate our relationship with them. After evaluating several options, it was determined I will perform this role and, consequently, my information should be listed as the Registered Agent and ZenBusiness' information should be removed from the Articles as shown in Exhibit 1.
- *Update to our Corporate Officers* — Currently Mr. Eric Schandel is identified in the Articles as our Corporate Secretary. Recently, Mr. Schandel has entered into a full-time engagement that represents a conflicting business interest preventing him from continuing to serve in this position. At the Shareholders Meeting, I was elected Corporate Secretary to replace Mr. Schandel. These changes

are reflected in the Articles of Amendment. Additionally, when filing the Articles with DOS, ZenBusiness identified a discrepancy between the list of Corporate Officers and Directors — When filing the Articles with DOS, ZenBusiness identified that Mr. Schandel was not identified within our Corporate Bylaws resulting in a discrepancy between the two documents. The Shareholders unanimously decided to maintain the Corporate Bylaws as written and to align the Articles of Amendment with the Director position. The associated revisions are shown in Exhibit 1.

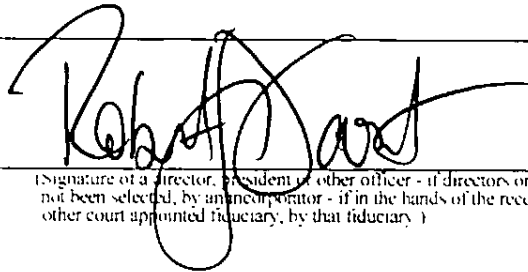
The Articles of Incorporation were prepared by a third-party who had been instructed to select the standard language for corporate purpose included on the DOC on line form. They were, however, unfamiliar with filing in Florida and thought it necessary to be more descriptive and, therefore, opted instead to copy text they found on a company brochure, which describes a subset of services provided by just one segment of the company. As such this text is not an accurate reflection of the company purpose. To correct this, the language currently included under Article III as shown below in **BOLD ALL CAPS** should be stricken in its entirety:

ARTICLE III. The purpose for which this corporation is organized is:  
**WE PROVIDE BRANDING, MARKETING, SALES CONSULTING AND SUPPORT SERVICES TO PROFESSIONAL SERVICE FIRMS, SUCH AS ENGINEERING, ARCHITECTURE, OR CONSTRUCTION COMPANIES. WE WORK WITH A SINGLE MISSION IN MIND: OUR CLIENT'S SUCCESS.**

Correct the inaccuracy, incorrect statement, or defect:

The Articles of Incorporation should be corrected by replacing the text stricken in full above with the standard language as shown below in **BOLD ALL CAPS**:

ARTICLE III. The purpose for which this corporation is organized is:  
**ANY AND ALL LAWFUL BUSINESS.**
