**ARTICLES OF INCORPORATION

In compliance with the requirements of the Florida Business Corporation Act (the "FBCA"), the undersigned hereby acts as an incorporator in adopting and filing these Articles of Incorporation to form a professional service corporation under Chapter 621 of the Florida Statutes and applicable laws.

**ARTICLE I: NAME**

The name of this corporation shall be:

**ARTICLE II: BUSINESS AND ACTIVITIES**

The nature of the business to be transacted by this Corporation is to practice public accounting in the State of Florida, pursuant to Chapter 473 of the Florida Statutes and applicable laws, through its officers, employees and agents, who are duly licensed and legally authorized to render such professional services within this state.

**ARTICLE III - CAPITAL STOCK**
