



The total number of shares of all classes of stock which the Corporation shall have authority to issue is 11,000,000 of which 1,000,000 shares of par value \$1.00 per share shall be designated as Common Stock and 10,000,000 shares of par value \$1.00 shall be designated as Preferred Stock.
