The total number of shares of all classes of stock which the Corporation shall have authority to issue is 11,000,000—of which 1,000,000—shares of par value \$1.00—per share shall be designated as Common Stock and 10,000,000 shares of par value \$1.00—shall be designated as Preferred Stock.
