



**ARTICLES OF INCORPORATION
RRC ROYAL HOLDINGS, P.A.**

a Florida professional service corporation

The undersigned, who is licensed to practice medicine in the State of Florida, for the purpose of forming a Florida professional service corporation under sec. 621.05, Fl. Stats., does hereby act as incorporator in adopting the following Articles of Incorporation.

ARTICLE I

The name of this corporation is RRC Royal Holdings, P.A. (hereinafter called the "corporation").

ARTICLE II

The corporation is organized under Ch. 621 of the Florida Statutes.

ARTICLE III

The corporation is authorized to issue only one class of shares of stock; and the total number of shares which the corporation is authorized to issue is three thousand (3,000) shares designated as "common stock".

ARTICLE IV

The purposes of the corporation shall be to own, operate and maintain an establishment for the practice of medicine, to carry on any function or lawful activity related to the practice of medicine and otherwise serve the convenience of its shareholders in conducting the practice of medicine; provided that the professional services in the course of such practice may be rendered only by persons who are duly licensed to practice medicine in Florida. The corporation shall have all the general rights, powers and privileges of corporations organized under Ch. 607 of the Florida Statutes, except as limited by sec. 621.01 through 621.14, Fl. Stats.

ARTICLE V

At such time as no shareholder of the corporation shall be licensed to practice in Florida, the corporation shall be converted into and shall operate thereafter solely as a business corporation under Ch. 607 of the Florida Statutes.

ARTICLE VI
