ARTICLE I

NAME, PRINCIPAL PLACE OF BUSINESS, AND DURATION

The name of the Corporation is LAW OFFICES OF SYLVANA ROSENDE, P.A. ("Corporation"). The principal place of business of the Corporation is 9576 NW 41st ST, Doral, Florida 33178. The duration of the Corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

ARTICLE III

CORPORATE PURPOSES, POWERS, AND RIGHTS

1. The nature of the business to be conducted or promoted is to engage in the practice of law. 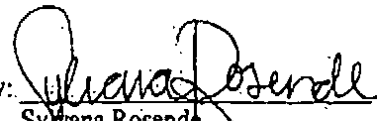
