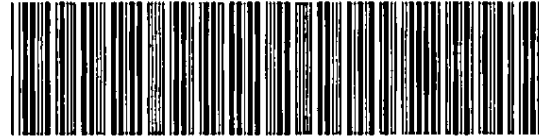




**SPECIAL AND REVOCABLE

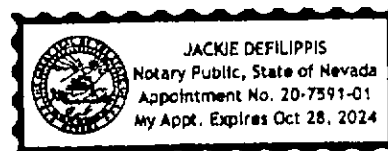
