#### ARTICLE I NAME

The name of this corporation is Nanoflow, Inc.

#### ARTICLE II DURATION

This corporation shall have perpetual existence, commencing on the date of filing of these Articles with the Secretary of State of the State of Florida.

## ARTICLE III PURPOSE

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

# ARTICLE V CAPITAL STOCK

- A. The corporation is authorized to issue 10,000,000 shares of \$0.0001 par value common stock, which shall be designated as "common shares."
