

ARTICLES OF INCORPORATION OF PUB INVESTMENT GROUP, INC.

a Florida corporation

In compliance with the requirements of Florida Statue Chapter 607, the undersigned hereby acts as the incorporator in adopting and filing the following articles of incorporation.

ARTICLE I NAME

The name of the corporation shall be Pub Investment Group, Inc. (the "Corporation").

ARTICLE II EXISTENCE

The existence of the Corporation shall begin on December 13, 2021 and shall exist in perpetuity until dissolved in accordance with the Florida Business Corporation Act and the bylaws of the Corporation.

ARTICLE III PRINCIPAL OFFICE

The street address of the initial principal office of the Corporation is 495 Town Plaza Avenue, Ponte Vedra, FL 32081.

ARTICLE IV PURPOSE

The Corporation is organized to transact any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act as it now exists or may hereafter be amended or supplemented.

ARTICLE V SHARES

The maximum number of shares that the Corporation is authorized to issue and have outstanding at any time is one million (1,000,000), all of which shall be common stock with a par value of \$0.01 per share. All common stock shall be identical with each other in every respect

ARTICLE VI PREEMPTIVE RIGHTS

The corporation elects to have no preemptive rights for shareholders.

ARTICE VII INITIAL DIRECTOR

The initial board of directors shall consist of one member. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws but shall never be less than one. The name and address of the individual who will serve on the initial board of directors is Morgan T. Busby.

ARTICLE VIII REGISTERED OFFICE AND AGENT

The Company hereby (a) designates 200 E. Forsyth Street, Jacksonville, FL, 32202 as the street address of the Company's registered office, and (b) names Peek & Miska as the Company's registered agent at that address to accept service of process within the State of Florida.
