ARTICLES OF INCORPORATION

OF

CHAPTERS CARENU, INC.

(A Florida Business Corporation)

The undersigned, acting on behalf of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation.

ARTICLE I

NAME AND ADDRESS

The name of the corporation is Chapters CareNU, Inc. (the "Corporation"). The Corporation's principal place of business is 12470 Telecom Drive, Suite 301, Temple Terrace, Florida 33637 and the Corporation's mailing address is 12470 Telecom Drive, Suite 301, Temple Terrace, Florida 33637.

ARTICLE II

The purposes of the Corporation include but are not limited to the following:

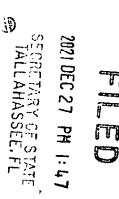
- (a) The Company is organized for any lawful purpose, and to do any and all things necessary, convenient, or incidental to that purpose; and
