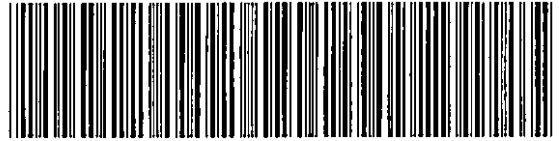

Article IV - "Authorized Shares and Shareholders" shall be amended and restated in its entirety as follows:

Article X - "Distribution Upon Dissolution" shall be amended and restated in its entirety as follows: "Upon the liquidation or dissolution of the Corporation, its assets, if any, remaining after payment (or provision for payment) of all liabilities of the Corporation, shall be distributed to the shareholders of the Corporation."
