ARTICLES OF INCORPORATION OF CHRISTIE L. GUERRERO, P.A.

The undersigned, acting as Incorporator of a Florida professional service corporation ("Corporation") under the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes, and other laws of the State of Florida, hereby causes to be delivered the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME

The name of the Corporation is Christie L. Guerrero, P.A.

ARTICLE II ADDRESS

COMMENCEMENT OF CORPORATE EXISTENCE

The corporate existence shall begin on December 28, 2021.

ARTICLE IV

PURPOSE

ARTICLE V

CAPITAL STOCK

The Corporation is authorized to issue one thousand (1,000) shares of Common Stock having a par value of \$0.01 per share.

<u>ARTICLE VI</u>

LIMITATION ON OWNERSHIP OF STOCK

No stock of this Corporation shall be issued to anyone other than an individual who is a duly licensed attorney at law, as those terms are used in Chapter 454, Florida Statutes, as may be amended from time to time, in the State of Florida.

ARTICLE VII

DISQUALIFICATION OF SHAREHOLDER OR EMPLOYEE

If any officer, shareholder, agent or employee of this Corporation, who has been rendering professional legal services to the public, becomes legally disqualified to render such professional legal services in the State of Florida or accepts employment that, pursuant to existing law, places restrictions or limitations upon his continuing rendering of such professional legal services, he shall sever all employment with, and financial interest in, this Corporation forthwith.

ARTICLE VIII

INITIAL BOARD OF DIRECTORS

The Corporation shall initially have one (1) director to hold office until the first annual meeting of shareholders and her successor(s) shall have been duly elected and qualified, or until her earlier resignation, removal from office or death. The number of directors may be either increased or decreased from time to time in accordance with the Bylaws of the Corporation.
