ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida under Chapter 607 of the Florida Statutes, being the Florida Business Corporation Act, to be filed with the Florida Department of State, as follows:

ARTICLE ONE: NAME

The name of the corporation is YPA Fidu, Inc., and its principal office address is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence as of 10 January 2022 and it shall exist perpetually thereafter until dissolved according to law.

No one dealing with the corporation shall be required to inquire as to the identification of the beneficiaries of any trust nor of the provisions or terms of any trust agreement. It shall be conclusively presumed that at the time of execution and delivery of any document by the corporation affecting any real property or any interest therein, a trust agreement was in full force and effect, such document was executed in full compliance therewith, and the corporation was duly authorized and empowered to execute and deliver such document.
