**ARTICLES OF INCORPORATION
OF

ARTICLE I – NAME

The name of the corporation is Cedar Mountain, Chartered (the “Corporation”).

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – DURATION; PURPOSE

The period of duration for the Corporation shall be perpetual.
