Attachment to Certificate of Incorporation of HELIAXE Inc.

The total number of shares of all classes of stock which the Corporation shall have authority to issue is 275,000 of which 250,000 shares of par value \$10.00 per share shall be designated as Common Stock and 25,000 shares of par value \$10.00 shall be designated as Preferred Stock.
