Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

A. The present name of the Florida Corporation for which these Articles of Amendment are filed is MELBOURNE INTERNAL MEDICINE, INC.

B. The Articles of Incorporation of the Company were filed on January 18, 2022 and assigned Florida document number P22000003697.

C. Article I of the Articles of Incorporation is hereby amended and restated in its entirety to read as follows:

"ARTICLE I - NAME

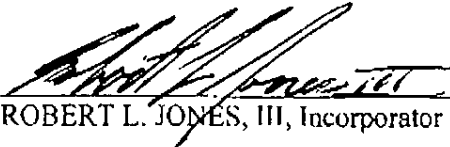
The name of this Corporation is **COASTAL INTERNAL MEDICINE OF MELBOURNE, INC."**
