Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Corporation adopts the following Articles of Amendment to its Articles of Incorporation:


- A. The present name of the Florida Corporation for which these Articles of Amendment are filed is COASTAL INTERNAL MEDICINE OF MELBOURNE, INC.
