**ARTICLES OF INCORPORATION  
OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is: Ainbinder Corporation.

**ARTICLE II**

The existence of the Corporation shall begin on the date of filing.

**ARTICLE III**

The street address of the initial principal office of the Corporation is: 5100 NW 33rd Ave., suite 247, Ft. Lauderdale, FL 33309. The mailing address is the same.

The maximum number of shares this Corporation is authorized to issue is one thousand, par value \$1.00 per share, all of which shall be Common Shares. 


