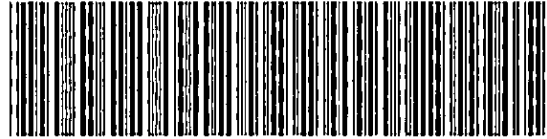

ARTICLE IV – NEW CORPORATE NAME

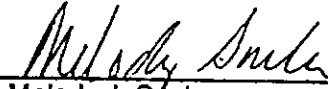

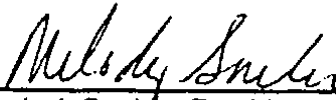
