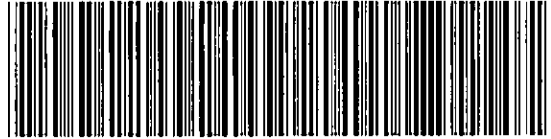

**ARTICLES OF INCORPORATION
OF
BOBBY'S BALLS, INC.**

This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

ARTICLE I – NAME

The name of the corporation is BOBBY'S BALLS, INC.

ARTICLE II – PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address of the corporation is 828 Duval Street, Key West, Florida 33040, and the principal office address of the corporation is the same.

ARTICLE III – REGISTERED AGENT AND ADDRESS

The address of the initial registered offices of the corporation shall be 221 Simonton Street, Key West, FL 33040, and the name of the initial registered agent for the corporation shall be Gregory S. Oropeza, a resident of the State of Florida.

ARTICLE IV - PURPOSE

The nature of the business and the objects and purpose or purposes to be transacted, promoted, or carried on by the corporation are to operate as a fast food restaurant and any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE V – AUTHORIZED SHARES

The total number of shares which this corporation is authorized to issue is 100 shares of common stock with One and 00/100 (\$1.00) Dollar par value for each share. Shareholders of the corporation shall have a preemptive right to purchase treasury or non-issued capital stock of the corporation and to vote their shares on a cumulative basis for the election of the Board of Directors.

ARTICLE VI – INITIAL OFFICER AND/OR DIRECTOR

The manner in which the officers and directors are elected is stated in the Bylaws of the corporation. The initial Board of Directors of the corporation shall consist of one (1) person, and
