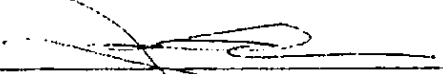

**ARTICLES OF INCORPORATION  
OF  
EVANS DATA CORPORATION**

**ARTICLE I**  
**Name and Duration**

The name of the Corporation is EVANS DATA CORPORATION. The duration of the Corporation is perpetual.

**ARTICLE II**  
**Principal Office**

The address of the principal office and mailing address of the Corporation is 340 Soquel Avenue, Santa Cruz, CA 95062.

**ARTICLE III**  
**Registered Office and Agent**

The street address of the registered office in the State of Florida is 14 East Bay Street, Jacksonville, Florida 32202, in the County of Duval. The name of the registered agent at such address is Milam Howard Nicandri & Gillam, P.A.

**ARTICLE IV**  
**Stock**

(a) The Corporation is authorized to issue two classes of stock, which shall be designated as "Common Stock" and "Preferred Stock", respectively. The number of shares of Common Stock authorized to be issued is One Hundred Million (100,000,000) shares, and the number of shares of Preferred Stock authorized to be issued is One Hundred Million (100,000,000) shares.

(b) The Preferred Stock may be issued from time to time in one or more series. The Board of Directors is authorized to fix the number of shares of any series of Preferred Stock and to determine the designation of any series. The Board of Directors is also authorized to determine or alter the rights, preferences, privileges, and restrictions granted to or imposed on any wholly unissued series of Preferred Stock and, within the limits and restrictions stated in any resolution or resolutions of the Board of Directors originally fixing the number of shares constituting any series, to increase or decrease (but not below the number of shares of such series then outstanding) the number of shares of any such series subsequent to the issue of shares of that series.

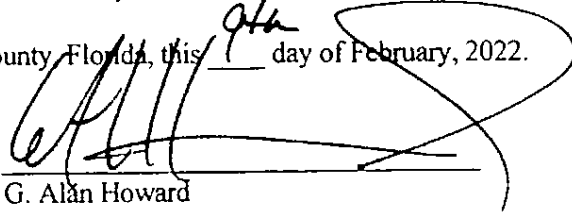
