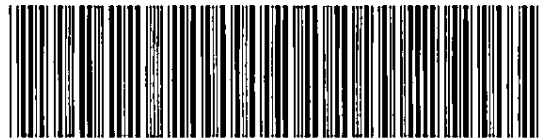

5. The effective date of conversion is the date of filing of these Articles of Conversion and the attached Articles of Incorporation..

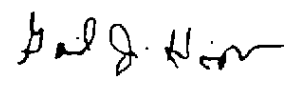
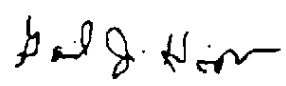

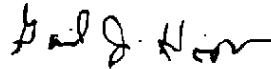
