Pursuant to the provisions of sections 607.1006 and 607.1007, Florida Statutes, JFH CLOVERLEAF PARTNERS, INC. adopts the following amendment and restatement to its Articles of Incorporation which were filed on February 16, 2022 and assigned Document #P22000011630.

ARTICLE I - NAME
