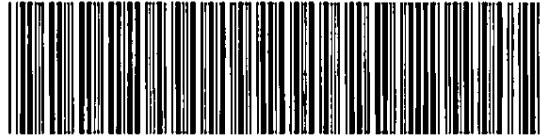

I, the undersigned subscribe to these Articles of Incorporation, a natural person competent to contract; hereby form a corporation under the laws of the State of Florida.

**Article I
Corporation Name**

The name of this processional service corporation is **BLANKENSHIP ENTERPRISE HOLDING INC.** The said address is **401 CENTURY 21 DR, SUITE E7, JACKSONVILLE FL, 32216**

**Article II
Nature of Business**

The general nature of business to be engaged in by this corporation is to hold and manage its subsidiaries and other companies for its stockholders. This company may also advise additional businesses, and individuals seeking to engage in the business of logistics, and commercial shipping. The division of the company may operate in the logistics industry for the purpose of warehousing, shipping, products, and goods for the general public. In addition, company may also operate a courier service for individuals looking to avail themselves of local deliveries, specifically in the Jacksonville, Florida area but not limited to that municipality

Company from time to time will solicit international contracts from individuals, and companies seeking to partner or pursue a joint venture. The division of the company may also engage in other activities to increase its revenue for its partners and stockholders. Company may also invest in real estate to rehab and sell for its personal gain.

This company will also engage in any other activities or business permitted under the laws of the State of Florida and the United States of America.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, manage, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares merchandise, real and personal property, and services, of every class, kind and description except that it is not to conduct a banking, safe deposit, trust, insurance, surety, express, railroad canal, telegraph, telephone, or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition. To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes or other evidences of indebtedness and execute such mortgages, transfer of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To produce corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge, or otherwise acquire or dispose of the shares of capital stock of, or any bonds, securities, or other evidences or indebtedness created by other corporations of the State of Florida, or any other state or government, and while owner of such stock to exercise all the rights, powers, and privileges or ownership, including the right to vote such stock.

ARTICLE III STOCK

The maximum number of shares of stock that the corporation is authorized to issues is 50,000 at a par value of four (\$3.00) dollars per share.

A. Shareholder of the corporations shall have the preemptive right to acquire their pro rata share of stock of the corporation and for all issues of the one class of common stock of the corporation and for all issues of the one class of common stock of the corporation no matter when authorized, and for whatever consideration is contemplated to be received by the corporation, including but not limited to: cash, other property, services, acquisition of other corporations, shares, or property through the merger or extinguishments of debts. Preemptive rights shall apply to the resistance of all redeemed or otherwise acquired shares, including the resistance of treasury shares.

B. This Article pertaining to preemptive rights may not be amended or deleted without the unanimous vote of the shareholders.

C. No issue of stock of the corporation shall take place unless the shareholders of the corporation shall unanimously approve the price at which the stock is to be issued.

D. There shall be no more than five (5) shareholders of this corporation at any time. Said shareholders may be real persons and/or legal entities such as corporations, association, or partnerships.

ARTICLE IV RESTRICTION ON TRANSFER OF SHARES

No shareholder shall have the right or power to pledge, sell, or otherwise dispose of, except by will any share or shares of this company without first offering the said share or shares for sale to the company and shareholders at the then book value.

ARTICLE V TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI PRINCIPAL PLACE OF BUSINESS

**ARTICLE XI


