- A. The present name of the Florida Corporation for which these Articles of Amendment are filed is TAYLOR DERMATOLOGY, P.A.
- B. The Articles of Incorporation of the Company were filed on February 22, 2022 and assigned Florida document number P22000013537.
- C. These Articles of Amendment are submitted to amend the Articles of Incorporation to add the following Article X:
