ARTICLES OF INCORPORATION

ARTICLE I-NAME

The name of this Corporation is: Mini Clean Inc.

ARTICLE II - DURATION

This Corporation is to exist perpetually, it shall commence existence on the date of filing of these Articles of Incorporation.


