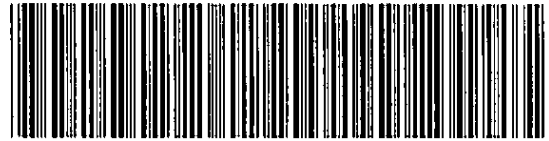

ARTICLE IV


The net assets of the Corporation remaining after winding up, if any, have been distributed to the shareholders, if shares were issued.
